- ② Click [Calibrate].
- ③ Using the stylus, touch each of the 16 "+" target marks one by one.

#### NOTE

- Perform the following calibration for each user.

- ① Click  (Start) - [Control Panel] - [Hardware and Sound] - [Tablet PC Setting].
  - ② Click [Calibrate].
  - ③ Using the stylus, touch each of the 4 "+" target marks one by one, and then click [Yes].
- Perform the calibration for the orientation to be used.

## Windows XP

- ① Click [start] - [All Programs] - [Fujitsu Touch Panel (USB)] - [Touch Screen Calibration Utility].
- ② Using the stylus, touch each of the 12 “+” target marks one by one until it blinks, and then press **Enter**.
- ③ Press **Enter**.

### 7 Create a new account.

Click [start] - [Control Panel] - [User Accounts] - [Create a new account].

## CAUTION

- Remember your password. If you forget the password, you cannot use the Windows operating system. Creating a password reset disk beforehand is recommended.


## NOTE

### ● PC Information Viewer

This computer periodically records the management information of the hard disk, etc. The maximum data volume for each record is 1024 bytes.

This information is only used for estimating the cause when the hard disk goes down by any possibility. They are never sent to outside via network nor used for any other purpose except for the purpose described the above.

To disable the function, add the check mark for [Disable the automatic save function for management information history] in [Hard Disk Status] of PC Information Viewer, and click [OK].


(→  *Reference Manual* “Checking the Computer’s Usage Status”)

### ■ Precaution against Starting Up/Shutting Down

- Do not do the following
  - Connecting or disconnecting the AC adaptor
  - Sliding the power switch
  - Touching the keyboard, touch pad, touchscreen (only for model with touchscreen), or external mouse
  - Closing the display
  - Turn on/off the wireless switch

## NOTE

- To conserve power, the following power saving methods are set at the time of purchase.
  - The screen automatically turns off after 15 minutes of inactivity.
  - The computer automatically enters sleep<sup>\*3</sup> (**Windows 7**)/standby<sup>\*3</sup> (**Windows XP**) after 20 minutes of inactivity.

<sup>\*3</sup> Refer to  *Reference Manual* “Sleep or Hibernation Functions” (**Windows 7**)/“Standby or Hibernation Functions” (**Windows XP**) about resuming from sleep.




**■ To set the screen saver**

When setting the screen saver, perform the following steps to select a standard Windows screen saver. However, do not select the [3D Text] or [Blank] screen saver.

- ① Right-click any blank area on the desktop, and click [Personalize].
- ② Click [Screen Saver].
- ③ Select any [Screen Saver] option other than [3D Text] and [Blank], and click [OK].  
If you select [3D Text] or [Blank], the computer may not transition properly into sleep mode or hibernation mode while the screen saver is active, due to incompatibilities with Windows 7. In addition, the computer may not resume from sleep mode or hibernation mode even when the power switch and keys are operated. In such cases, you will have to force shutdown by sliding and holding the power switch for four seconds or more, losing any unsaved data in the process.

**■ To change the partition structure**

You can shrink a part of an existing partition to create unallocated disk space, from which you can create a new partition. This computer has a single partition in the default setting.

- ① Click  (Start) and right-click [Computer], then click [Manage].
  - A standard user needs to enter an administrator password.
- ② Click [Disk Management].
- ③ Right-click the partition for Windows ("c" drive in the default setting), and click [Shrink Volume].
  - The partition size depends on the computer specifications.
  - To select [Reinstall to the first 2 partitions.] in reinstalling Windows 7 (→ page 21), 30000 MB or more is necessary for [Total size after shrink in MB].
- ④ Input the size in [Enter the amount of space to shrink in MB] and click [Shrink].
  - You cannot input a larger number than the displayed size.
- ⑤ Right-click [Unallocated] (the shrunk space in the step ④) and click [New Simple Volume].
- ⑥ Follow the on-screen instructions to make the settings, and click [Finish].  
Wait until formatting is completed.

**NOTE**

- You can create an additional partition using remaining unallocated space or newly creating unallocated space.
- To delete a partition, right-click the partition and click [Delete Volume] in the step ③.

## Operation environment

- Place the computer on a flat stable surface. Do not place the computer upright or turn it over. If the computer is exposed to an extremely strong impact, it may become inoperable.
  - Temperature: Operation : 5 °C to 35 °C {41 °F to 95 °F}  
Storage : -20°C to 60 °C {- 4 °F to 140 °F}
  - Humidity: Operation : 30% to 80% RH (No condensation)  
Storage : 30% to 90% RH (No condensation)
- Even within the above temperature/humidity ranges, using for a long time in an extreme environment will result in the product deterioration and will shorten the product life.
- Do not place the computer in the following areas, otherwise the computer may be damaged.
    - Near electronic equipment. Image distortion or noise may occur.
    - In extremely high or low temperature.
  - As the computer can become hot during operation, keep it away from items that are sensitive to heat.

## Handling cautions

This computer is designed to minimize shock to parts such as the LCD and the hard disk drive and equipped with a drip-proof keyboard, but no warranty is provided against any trouble caused by shock. Be extremely careful when handling the computer.

- When carrying the computer:
    - Turn off the computer.
    - Remove all external devices, cables, PC Cards and other protruding things.
    - Remove a disc in the CD/DVD drive.
    - Do not drop or hit the computer against solid objects.
    - Do not leave the display open.
    - Do not grip the display part.
  - Do not put anything (e.g., a piece of paper) between the display and keyboard.
  - When you board an airplane, take the computer with you and never put it in your checked luggage. When using the computer on airplane, follow the airline's instructions.
  - When carrying a spare battery, put it in a plastic bag to protect its terminals.
  - The touch pad is designed to be used with a finger tip. Do not place any object on its surface and do not press down strongly with sharp-pointed or hard objects that may leave marks (e.g., nails, pencils and ball point pens).
  - Avoid any harmful substances such as oil from getting into the touch pad. The cursor may not work correctly.
  - Be careful not to get injured by dropping down or getting hit when carrying the computer.
- <Only for model with touchscreen>
- Use only the included stylus to touch the touchscreen. Do not place any object on its surface and do not press down strongly with sharp-pointed or hard objects that may leave marks (e.g., nails, pencils and ball point pens).
  - Do not use the stylus when dust or dirt (e.g., oil) is on the screen. Otherwise foreign particles on the screen/stylus can scratch the screen surface or obstruct the stylus operation.
  - Use the stylus only for touching the screen. Using it for any other purpose may damage the stylus and result in scratches on the screen.

### ■ When using peripheral devices

Follow these instructions and the Reference Manual to avoid any damage to the devices. Carefully read the instruction manuals of the peripheral devices.

- Use the peripheral devices conforming to the computer's specifications.

## Maintenance

### To clean the LCD panel

<Only for model with touchscreen>

Use the soft cloth included with the computer. (For further information, refer to “Suggestions About Cleaning the LCD Surface” that comes with the soft cloth.)

<Only for model without touchscreen>

Wipe with a soft dry cloth such as gauze.

### To clean areas other than the LCD panel

Wipe with a soft dry cloth such as gauze. When using detergent, dip a soft cloth in water-diluted detergent and wring it thoroughly.

### CAUTION

- Do not use benzene, thinner, or rubbing alcohol since it may adversely affect the surface causing discoloration, etc. Do not use commercially-available household cleaners and cosmetics, as they may contain components harmful to the surface.
- Do not apply water or detergent directly to the computer, since liquid may enter inside of the computer and cause malfunction or damage.

# Reinstalling Software

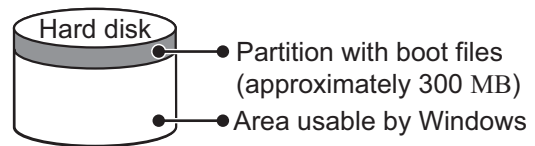
Reinstalling software will return the computer to the default condition. When you reinstall the software, the hard disk data will be erased.

Back up important data to other media or an external hard disk before reinstallation.

## CAUTION

### Windows 7

Do not delete the partition with boot files on the hard disk.  
The disk space in the partition is not available to store data.



## NOTE

- **Windows 7** Bluetooth™ is not capable.

## Preparation

- Prepare the following items:
  - The Product Recovery DVD-ROM (included)
  - Panasonic CD/DVD drive (optional)
- Remove all peripherals (except for the CD/DVD drive).
- Connect the AC adaptor and do not remove it until reinstallation is complete.

### 1 Turn off the computer and insert the CD/DVD drive into the multimedia pocket (→ *Reference Manual* “Multimedia Pocket”).

When reinstalling Windows XP from Windows 7:

- ① Turn on the computer, and press **F2** or **Del** while [Panasonic] boot screen is displayed.
- ② Set the Product Recovery DVD-ROM for Windows 7 into the CD/DVD drive.
- ③ Select the [Exit] menu, then select [UIDA760 DVD/CDRW] or [MATSHITADVD-RAM UJ-8415] in [Boot Override].
- ④ Press **Enter**.
- ⑤ Select [Run “System Recovery Options.”], and click [Next].
- ⑥ Click [Next], and then click [Next].
- ⑦ Select [Command Prompt].
- ⑧ Enter “e:\util\recovery\BscBluet.exe /ON” and press **Enter**. (In this case, CD/DVD drive is assigned to “e:.”.)
- ⑨ Enter “exit” and press **Enter** to quit [Command Prompt].
- ⑩ Remove the Product Recovery DVD-ROM for Windows 7 from the CD/DVD drive.
- ⑪ Click [Shut Down] in [System Recovery Options] to turn off the computer.

### 2 Turn on the computer, and press **F2** or **Del** while [Panasonic] boot screen is displayed. The Setup Utility starts up.

- If the password is requested, enter the Supervisor Password.

### 3 Write down all of the contents of the Setup Utility and press **F9**.

At the confirmation message, select [Yes] and press **Enter**.

### 4 Press **F10**.

At the confirmation message, select [Yes] and press **Enter**.  
Computer will restart.

### 5 Press **F2** or **Del** while [Panasonic] boot screen is displayed.

The Setup Utility starts up.

- If the password is requested, enter the Supervisor Password.

### 6 Set the Product Recovery DVD-ROM for Windows which you install into the CD/DVD drive.

### 7 Select the [Exit] menu, then select [UJDA760 DVD/CDRW] or [MATSHITADVD-RAM UJ-841S] in [Boot Override].

### 8 Press **Enter**.

The computer will restart.

### 9 Click [Reinstall Windows] and click [Next].

The License Agreement screen appears.

### 10 Click [Yes, I agree to the provisions above and wish to continue!] and click [Next].

### 11 When reinstalling Windows 7 from Windows 7:

Select the settings and click [Next].

- [Reinstall Windows to the whole Hard Disk to factory default.]  
You will have two partitions.

- [Reinstall to the first 2 partitions.]<sup>\*1</sup>

Select this option when the hard disk has already been divided into several partitions. For how to create a new partition, refer to “To change the partition structure” (→ page 17).

You can keep the partition structure.

<sup>\*1</sup> This does not appear if Windows cannot be reinstalled to the partition containing boot files and the area usable by Windows.

### 14 Turn on the computer.

- If the password is requested, enter the Supervisor Password.

### 15 Perform the “First-time Operation” (→ page 14).

### 16 Start the Setup Utility and change the settings as necessary.

### 17 Perform Windows Update.

#### Windows XP

### 9 Press **1** to execute [1. [Recovery]].

The License Agreement screen appears.

- To cancel partway, press **0**.

### 10 Press **1** to select [1. Yes, I agree to the provisions above and wish to continue!].

### 11 Select the settings.

- [2]: Enter the size of operating system partition and press **Enter**.  
(The size of data partition will be determined by subtracting the operating system partition size from the maximum size.)
- [3]: Windows will be installed in the first partition.  
(The size of the first partition must be 30 GB or more. If smaller, installation will not be possible.)

At the confirmation message, press **Y**.

Reinstallation starts automatically. (It will take approximately 30 - 75 minutes.)

- Do not interrupt reinstallation, for example by turning off the computer or pressing **Ctrl + Alt + Del**. Otherwise reinstallation may become unavailable as Windows may not start up or the data may be corrupted.

### 12 Remove the Product Recovery DVD-ROM, and then press any key to turn off the computer.

- If additional instructions are included with the computer, be sure to read them. It may be necessary to perform additional operations during the following procedure.

### 13 Turn on the computer.

- If the password is requested, enter the Supervisor Password.

### 14 Perform the “First-time Operation” (→ page 14).


### 15 Start the Setup Utility and change the settings as necessary.

#### ■ To change the drive letter of hard disk or CD/DVD drive


